MISSION

West Brownsville Little League (WBLL) strives to provide a healthy environment in which the youth of our community can play Baseball and Softball. We strive to provide quality instruction in the development of baseball/softball skills while teaching the qualities of sportsmanship, teamwork, honesty, loyalty, integrity, competitiveness, fair play, and community pride.

West Brownsville Little League, an IRS-approved 501c3 non-profit entity, is recognized as the oldest youth sports organization in our community with a record of 70+ years of continuous operation since 1952. Our league operates under the auspices of Little League International, one of the largest volunteer organizations in the US and the world. Locally, our board is made up of 20+ volunteer members whose primary focus is to grow our league and steer its year-round activities. The league conducts its regular activities with an army of volunteers who serve as team managers, coaches, team moms, and Challenger Division buddies. We register boys and girls aged 4-15 for baseball and softball. We are also very proud of the recent addition of our Challenger Division for children with special needs. We strongly believe in the inclusivity of all children of all abilities.

BOARD OF DIRECTORS

WBLL maintains a 20+ member Board of Directors whose primary focus is to manage and steer the monthly activities of the league. Serving on our board can be rewarding and professionally fulfilling. Board member obligations include participation in periodic meetings that vary depending on the time of year. Board members also participate in fundraising, vendor selection, sponsor recruitment, coaching search, park maintenance, player registration, and game scheduling. Experience in baseball or softball is not required. Board members are elected annually at the general membership meeting held on or around the third Tuesday in October. To be considered, nomination forms should be completed and returned at least one week before the election meeting.

Term: Board members serve a one-year term unless elected to an officer position. Officers serve a two-year term.

Meetings / Activities: Vary by month, as needed, with a minimum of one event each month July through December, and two or more per month January through June.

Time Commitment: (July – December) Five to ten hours per month; (January – June) ten to twenty hours per month.
